SECOND PHASE ALLOTMENT TO B.PHARM (LATERAL ENTRY) COURSE-2024 **FACILITY FOR ONLINE OPTION CONFIRMATION**

The second phase Centralised Allotment Process for admission to B.Pharm (LE) Course in the Government Pharmacy Colleges and Private Self-financing Pharmacy Colleges of the State for the year 2024-25 commences on **25.01.2025**.

Candidates who are having valid options and who are willing to participate in the second allotment have to log in to his/her Home page and confirm their options by clicking the **Confirm** button accessible through the link '**Option Registration**'. Thereafter, the options carried over from the previous phase will become accessible and the candidates can delete their unwanted options or alter their priority for existing options. If a candidate does not confirm the higher order options by clicking the 'Confirm' button available in his/her Home page, his/her higher order options will not be considered for seat allotment. However, his/her, existing allotment, if any, shall be retained.

The facility for online option confirmation/deletion/rearrangement will be available on the website **www.cee.kerala.gov.in** from **25.01.2025 to 28.01.2025, 5.00 PM**. Those who do not confirm their options online within the stipulated time will not be considered for this phase of allotment.

The annual tuition fees in self-financing pharmacy colleges is provisional and will be subject to be final decision of Government. The annual tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission. SC/ST/OEC/Children of Fisherman/inmates of Sri Chithra Home, Nirbhaya Home and Juvenile Home candidates are exempted from payment of fees. Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.
