SECOND PHASE ALLOTMENT TO B.PHARM (LATERALENTRY) COURSE-2025 FACILITY FOR ONLINE OPTION CONFIRMATION

The second phase Centralised Allotment Process for admission to B.Pharm (LE) Course in the Government Pharmacy Colleges and Private Self- financing Pharmacy Colleges of the State for the year 2025-26 commences on 16.12.2025. Candidates who are having valid options and who are willing to participate in the second allotment have to log in to his/her Home page on the website, www.cee.kerala.gov.in, and confirm their options by clicking the 'Confirm button' accessible through the link 'Option Registration'. Thereafter, the options carried over from the previous phase will become accessible and the candidates can delete their unwanted options or alter their priority for existing options. If a candidate does not confirm the higher order options by clicking the 'Confirm' button available in his/her Home page, his/her higher order options will not be considered for seat allotment. However, the existing allotment shall be retained if the candidate has taken admission. The facility for online option confirmation/deletion/rearrangement will be available on the website www.cee.kerala.gov.in from 16.12.2025 to 19.12.2025, 10.00 AM.
