ADMISSION TO B.PHARM (LATERAL ENTRY) COURSE -2025 **APPLICATION INVITED**

Applications are invited from eligible candidates for the Entrance Examination for admission to B. Pharm Course [through Lateral Entry] for the year, 2025 in the Government and Private-Self Financing Pharmacy Colleges, in the state of Kerala.

Eligibility for Admission

Nativity: The applicant should be an Indian citizen of Kerala origin. (see clause 4.1 of the prospectus for admission to B.Pharm (LE)-2025 for more details)

i. Academic qualifications:

- a) Candidates should have studied Diploma in Pharmacy (Under Education Regulations 2020 of the Pharmacy Council of India) in an institution approved by the Pharmacy Council of India and passed the Diploma in Pharmacy examination conducted by the Kerala State Board of D. Pharm Examinations or equivalent with a minimum of 50% marks in the final year examinations.
- b) Candidates should have obtained registration with the State Pharmacy Council and the registration Certificate is to be produced at the time of Counseling.

OR

Candidates should have applied for registration with State Pharmacy Council and the proof thereof is to be produced at the time of CEE/483/2025-TA2 I/469433/2025

counseling.

iii. Age: There is no upper age limit for admission to the course.

Entrance Examination

Selection of candidates for B.Pharm (Lateral entry) course 2025 will be made on the basis of a Computer Based Test to be conducted on 23.11.2025 by the Commissioner for Entrance Examinations at various centers in Kerala. It will consist of one Paper of one and half hrs (90 minutes) duration and have 120 Questions. The scheme of the Computer Based Test, syllabus and the instructions to the candidates are available in Clause 8 of the Prospectus for Admission to B.Pharm (Lateral entry) course 2025.

Submission of Online Applications

All eligible candidates seeking admission to B.Pharm (Lateral entry) course 2025 can apply through the Online application portal provided on the website www.cee.kerala.gov.in of the Commissioner for Entrance Examinations. Applicants have to remit the application fee by way of online payment. After remitting the required application fee, recent photo and signature of candidate are to be uploaded. Thereafter all necessary certificates/documents should be uploaded. After completing the uploading of all necessary certificates/documents, candidates can take printout of the Application Acknowledgment page. A copy of the Acknowledgement page has to be kept by the candidate for future reference. *Do not send printout of the Acknowledgement page or any documents to the Commissioner for Entrance Examinations*.

Application Fee

Application Fee for General Candidates is Rs.800/- (Rupees Eight hundred only) and for SC candidates is Rs.400/- (Rupees Four hundred

only). ST Candidates are exempted from the payment of application fee. The application fee once remitted will not be refunded.

Last date and time for online submission of application

All candidates seeking admission to the course shall submit their applications online and upload the certificates/documents specified in Clauses 7.3.5 and 7.3.6 of the Prospectus on or before 4:00 p.m. on 15.11.2025.

Candidates who require additional time to obtain certificates in support of claims for reservation, fee concession, etc. may upload the relevant documents **up to 20.11.2025**.

Defective or incomplete applications shall be summarily rejected, and no correspondence will be entertained in this regard. Candidates shall not be permitted to add any information to the application or to submit any certificates/documents in support of claims for reservation or other benefits after the submission of the application, except as provided in the above paragraph.
