As per the letter read above , Directors of IHRD, CAPE and LBS had requested Government to change the status of their institutions in the KEAM Prospectus from Government Controlled Self Financing College to Government Cost-Sharing Engineering Colleges. The matter was discussed in the KEAM 2022 Prospectus Revamp Committee Meeting held on 22.02.2022.

Government examined the matter in detail.The fee structure of courses under IHRD,LBS,CAPE,CCEK and SCTCE Engineering colleges are fixed by Government which is lower than the Private self financing Colleges.However,as these colleges are also listed as Self financing colleges in the KEAM prospectus,the students consider these three institutions also at par with other private self financing colleges where the fee structure is much higher. The request read above is based on this situation.
