ADMISSION TO MBBS & BDS COURSES-2023 STRAY VACANCY FILLING

MBBS

If the allotted candidate do not join the course within the prescribed time limit, further allotment will be published by the Commissioner for Entrance Examinations to fill the vacant seat.
