## **ORDER**

1. The Fee Regulatory Committee, by order dated 18.06.2018 has fixed the Tuition fee and Special fee for the Pharmacy Association, Kerala State Self -Financing Pharmacy College Managements Association, (KSSPCMA) for the B.Pharm, M.Pharm, Pharm D and Pharm D PB courses for the academic year 2018-19. All the Self Financing Pharmacy Colleges in Kerala, has adopted the same fee structure fixed by the Committee as per the table shown below.
