The activities related to the third phase allotment to the Kerala Ayurveda/ Homoeopathy/ Siddha/ Unani/ Pharmacy/ Agriculture/ Veterinary/ Forestry / Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/B.Tech Biotechnology courses (Under Kerala Agricultural University) for the State Quota Seats commenced on **18.10.2023.**

Online Option Registration is mandatory

In this round, a fresh option registration facility is available to the candidates. Candidates who wish to participate in this round shall have to register options through the website www.cee.kerala.gov.in from 18.10.2023 to 21.10.2023, 4.00 PM. On the basis of the options received up to 4.00 PM on 21.10.2023 the third phase provisional allotment to Ayurveda/ Homoeopathy/Siddha/Unani/ Pharmacy and Medical Allied courses will be published in the website www.cee.kerala.gov.in on 24.10.2023. The previous options registered by the candidates will not be considered in this phase. Candidates who receive allotment in this phase shall have to take a printout of their allotment memo and remit the fee/balance fee (if applicable) shown in the allotment memo, to the allotted colleges and should join the course/college allotted.

Option Registration Fee:

In the case of those candidates who have already paid the registration fee in the First phase allotment and not get allotment, need not pay the registration fee again. But those candidates who are included in the rank list who wish to register afresh have to pay Rs.5000/- as registration fee at the time of option Registration. Candidates belonging to SC/ST/OEC category eligible for benefits as per G.O (MS) 25/2005 /SCSTDD dated 20.06.2005 and G.O. (MS) No.10/2014/BCDD dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechitra Home will have to remit Rs.500/- as registration Fee. Those candidates who get an allotment and take admission in this phase, the registration fee will be adjusted to the tuition fee or if the candidates does not get an allotment in this or subsequent phases, registration fee will be refunded after the completion of the entire counselling process. The registration fee of candidates eligible for fee concession who takes admission in the allotted college will be refunded. The registration fee of those candidates who do not join, vacate or lapse the allotted seats, after the date to be decided by the Commissioner for

FEES

Pharmacy and Medical Allied courses, in various colleges will be available in the

allotment memo. As the fee for 2023-24 academic year is not yet fixed in Self

Financing colleges, those candidates who get allotment in Self Financing colleges

should provisionally pay the fee fixed for 2022-23 academic year and they have to

pay the balance fees in case if the fee to be fixed by the Admission Supervisory

Committee/Government/Hon'ble High Court for the academic year 2023-24 is

going to be higher than that of 2022-23 for these colleges.

Candidates allotted under SC/ST/OEC category and those having benefits

as per G.O((MS)25/2005/SCSTDD, dated: 20.06.2005 and

G.O(MS)10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra

Home, Juvenile Home, Nirbhaya Home need not to pay the fee at the time of

admission.
