# CENTRALISED SECOND PHASE ALLOTMENT TO ENGINEERING COURSES AND FIRST PHASE ALLOTMENT TO ARCHITECTURE COURSE PUBLISHED

The second phase allotment to Engineering Courses and first phase allotment to Architecture Courses-2023 are published on the website **www.cee.kerala.gov.in**.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate as well as in the Allotment Memo.

#### **Allotment Memo and Data Sheet**

Candidates who have an allotment should take a printout of Allotment Memo from the home page. The Allotment Memo available in this phase will not be available later. Hence, candidates shall have to keep copy of the Allotment Memo for future reference. Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the home page. The printout of the Allotment Memo and Data Sheet along with the documents prescribed (as applicable) in clause 11.7.1 of the Prospectus are to be produced before the college authorities at the time of admission.

#### **Fee Payment**

Candidates who receive an allotment afresh should remit the fees to be

paid to the Commissioner for Entrance Examinations as specified in the Allotment Memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **14.08.2023 to 19.08.2023, 2.00 PM** and should join the course/college allotted before **3.00 PM on 19.08.2023.** The list of Post Offices having facility for fee payment is available in the website.

The candidates who get a change in allotment other than that of the first allotment should pay the balance fee, if applicable, by any of the method and within the time mentioned above. These candidates should also join the course/college allotted as per the Allotment Memo before **3.00 PM on 19.08.2023.** 

Candidates shall have to remit the fees applicable to the allotted colleges at the time of admission.

Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.

## **Joining Schedule**

All the candidates who have an allotment should join the course/college allotted as per the Allotment Memo from 14.08.2023 to 19.08.2023. The detailed schedule showing the date and time for joining the Engineering and Architecture courses will be published by the Colleges in their websites. Candidates who have got allotment shall have to visit the website of the allotted College in order to have information regarding the date and time of the joining. Candidate shall have to join the allotted college as per the schedule prescribed by the college.
