THIRD PHASE ALLOTMENT TO ENGINEERING AND SECOND PHASE
ALLOTMENT TO ARCHITECTURE COURSES-2023
FACILITY FOR ONLINE OPTION CONFIRMATION AVAILABLE

The activities related to the third phase of allotment to Engineering Courses and second phase allotment to Architecture Course began on 23.08.2023. This phase of allotment will be the last phase allotment for this year made by the Commissioner for Entrance Examinations to Government/Government Cost Sharing, Autonomous and Private Self Financing Engineering/Architecture Colleges. The seats remain vacant after this allotment will be filled by the Director of Technical Education in the case of Government Colleges and that of other colleges will be filled by the College authorities concerned observing the conditions, rules and regulations contained in the KEAM 2023 Prospectus and Government Orders issued in this regard.

Online Option Confirmation is mandatory for Engineering and
Architecture Courses

Candidates who want their higher order options in Engineering and Architecture, courses to be considered in this phase of allotment shall have to log into their **Home Page** and confirm their options by clicking the '**Confirm**' button available therein. After **Online Option Confirmation**, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges, if any, from **23.08.2023 to 26.08.2023, 04.00 PM**, through the website **www.cee.kerala.gov.in**. On the basis of options received up to **04.00 PM** on **26.08.2023**, the allotment to Engineering and Architecture courses will be published on **03.09.2023**.

Online option confirmation is a must for those who got admission and those who got no allotment as per the last phase allotment, to consider them in this phase allotment in the case of Engineering and Architecture courses.

But those who do not confirm options after admission, the allotment in the last phase shall be retained. Online Option Confirmation is mandatory for being considered in this phase of allotment for candidates admitted with a course in previous phases and those who have not received any allotment in the previous phases.

Those candidates who did not join the college/courses consequent on the last phase allotment on or before the date prescribed for the same will lose their allotment as well as all the options in the stream to which the allotment belongs.
