- (a) shall remit Rs.50,000/- each(Rupees Fifty thousand only) as Application fee and Processing fee respectively under the head of account 0210-03-101-97-01 (Application fee) 0210-03-101-97-02 (Processing fee)
- (b) shall provide all facilities viz. Laboratories, classrooms, faculties, etc. as per Pharmacy Council of India Educations Regulations 1991, before the commencement of the course,
- (c) shall set up separate office rooms for establishment and academic work,
- (d) shall produce a letter of approval from the Pharmacy Council of

India for the enhanced seats and conducting the course,

- (e) shall agree to admit students on 50% merit and 50% management basis and that the merit seat students shall be admitted from the State merit list prepared by the Director of Medical Education/ Commissioner for Entrance Examinations and 50% seats by management at the rate of the fee fixed by the Government from time to time and subject to the conditions in the prospectus for each year, and
- (f) shall execute an agreement and submit an affidavit with the Government in the Health& Family Welfare(K) Department in respect of (e) above.
- 3. The NOC shall be withdrawn if the Institution violates any of the conditions listed above.
