OPTION REGISTRATION FOR THIRD PHASE ALLOTMENT
TO PHARMACY COURSE - FACILITIES AVAILABLE

The activities related to the third phase allotment to Pharmacy Course began on **14.08.2026**.-

Fresh Online Option Registration for Pharmacy Course

Fresh Online option registration facility is available for Pharmacy course in the third phase. Eligible candidates included in the Pharmacy rank list published by the Commissioner for Entrance Examinations can register their options through the website **www.cee.kerala.gov.in** from **14.08.2026 to 16.08.2026, 11.59 PM**. On the basis of options received up to **16.08.2026, 11.59 PM** the provisional allotment to Pharmacy course will be published on **18.08.2026**.

Online option registration for Pharmacy Course is a must for those who got admission and those who got no allotment as per the previous allotments, to consider them in this phase. But those who got an allotment/admission in the previous phases and do not register options for this phase, the admission through the allotment in the previous phase shall be retained.

Those candidates who get allotment in this phase and do not join the college on or before the date prescribed for the same will lose their allotment in the last phase and the allotment in this phase .

19.08.2026	Publication of Final Allotment
20.08.2026 to 22.08.2026, 4.00 PM	Candidates who get allotment shall have to pay the fees to the Commissioner for Entrance Examinations as shown in the allotment memo through online payment and should join the allotted colleges.

Option Registration Fee:

Those candidates who wish to register options afresh will have to remit registration fee of Rs.2,000/- (Rupees Two Thousand Only) to the Commissioner for Entrance Examinations. The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent on allotments. Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/ SCSTDD Dated 20.06.2005 and G.O.(Ms)No.10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chitra Home will have to remit Rs.500 /- (Rupees Five Hundred only) as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. The Registration Fee of those candidates who do not take admission will be treated as penalty and will not be refunded. Registration Fees can be remitted by way of online payment.

Note :- Candidates who fail to register options in this phase will not be considered for allotment under any circumstances.
