## NOTIFICATION ALLOTMENT TO B.Tech (LATERAL ENTRY) COURSE 2020-21 FIRST PHASE OF ALLOTMENT PUBLISHED

The First Phase of Centralised Allotment (CAP) for admission to B.Tech. (Lateral Entry) Course in the Engineering Colleges of the State for the year 2020-21 is published herewith in the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a>. The allotment is based on the online options registered by candidates up to 12.00 PM on 16.11.2020. Candidates belonging to BSc. Stream are not included in this phase. They shall be considered for allotment in the second phase after considering all the eligible applicants belonging to the Diploma and D.Voc. streams.

Candidates can access their homepage by entering their Application number, and Password in the 'B.Tech. (Lateral Entry) 2020- Candidate Portal' provided in the above website. Then by clicking the menu item 'Allotment Result', candidates can view their Allotment details. Candidate can download their Allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit, if any, etc. are available in the Allotment Memo. Candidates shall have to take a print out of the Allotment Memo. Candidates can also log into their Home page and click the Menu item 'Data Sheet' for downloading the Data Sheet.

Candidates who receive allotment in this phase shall have to take a print out of the Allotment memo and remit the fee to be paid to the Commissioner for Entrance Examinations by way of Online Payment or at any of the Head Post Offices in Kerala and should report for admission before the Principal of the allotted colleges on any date from 19.11.2020 to 21.11.2020, 3.00 pm along with the Allotment memo, Data sheet and original documents specified in the Notification dated 09.11.2020 and given in the allotment memo. Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees. However they shall have to pay fees applicable to management seats, if allotted to management seats in Government Controlled Self-financing colleges.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **4 pm on 21.11.2020.** 

The candidates who do not join the college within the stipulated time will lose their present allotment and also their higher order options. Also such candidates will not be considered for future online centralized allotments, if any.

Malabar Institute of Technology, Anjarakkandy (MLT) which had been included in the option list is excluded from the allotment. The branch Electrical and Electronics Engineering (EE) offered by Sree Narayana Guru Institute of Science and Technology (SNT), North Paravur which had been included in the option list is also exempted from the allotment.

The Second and last phase of centralized allotment for admission to B.Tech (Lateral Entry) Course will start from 20.11.2020 onwards. Detailed notification regarding the Second Phase of allotment will be published later.
