**ALLOTMENT TO B.TECH (LATERAL ENTRY) COURSE 2020-21**  
**SECOND PHASE OF ALLOTMENT PUBLISHED**

The Second Phase of Centralised Allotment (CAP) for admission to B.Tech. (Lateral Entry) Course in the Engineering Colleges of the State for the year 2020-21 is published herewith in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment is based on the online options registered by candidates up to **12.00 PM on 22.11.2020**.

Candidates can access their homepage by entering their Application number, and Password in the '**B.Tech (Lateral Entry) 2020 - Candidate Portal**' provided in the above website. Then by clicking the menu item '**Allotment Result**', candidates can view their Allotment details. Candidate can download their Allotment memo. Details such as candidate's name, roll number, allotment details, tuition fees, deposit, if any, etc. are available in the Allotment Memo. Candidates shall have to take a print out of the Allotment Memo. Candidates can also log into their Home page and click the Menu item '**Data Sheet**' for downloading the Data Sheet.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.

Candidates who receive fresh allotment or a change in allotment than the previous phase shall have to take a print out of the Allotment memo and remit the fee, balance fee, as the case may be, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or at any Head Post Offices in Kerala and should report for admission before the Principal of the allotted colleges on **23.11.2020 or 24.11.2020, 4.00 pm** along with the Allotment memo, Data Sheet and original documents specified in previous notifications and in the Allotment Memo. Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees. However, they shall have to pay fees applicable to Management seats, if allotted to management seats in Government Controlled Self Financing Colleges.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at 5 pm on 24.11.2020.

The candidates who do not join the college within the stipulated time will lose their present allotment and also their higher order options. Also such candidates will not be considered for future online, if any, under Centralized Allotment Process.
