To view the Allotment Result, candidates should log on to the 'Integrated Five Year LLB 2023-Candidate Portal' by submitting their Application Number and Password. Then by clicking on the link 'Allotment Result', candidates can view their Allotment Result. It is necessary to take the printout of the Allotment Memo. The allotted candidates should report for joining at the allotted colleges from 07.11.2023 to 09.11.2023, 3.00 PM, along with all required documents specified in the Allotment Memo as per Prospectus clause 18.

Course once allotted in the Mop-up Allotment shall be final and cannot be changed further and if the candidates, who have been already admitted to Integrated Five Year LLB course through previous phases of allotment by Commissioner for Entrance Examinations, get an allotment through the Mop up
