**ADMISSION TO INTEGRATED FIVE YEAR LLB COURSES 2026**  
**FIRST PHASE FINAL ALLOTMENT PUBLISHED**

The First Phase Centralized Allotment for admission to Integrated Five Year LL.B Course in 4 Government Law Colleges and Government Seats in 32 Private Self-financing Law Colleges of the State for the year 2026-27 is published in the website **[www.cee.kerala.gov.in](http://www.cee.kerala.gov.in)**. The allotment is based on the rank in the rank list of Integrated Five Year LLB course published by the Commissioner for Entrance Examinations and online options registered by the candidates from **10.08.2026 to 15.08.2026, 10.00 AM**. The online options registered by the candidates whose results are withheld have not been considered for allotment.

Candidates can access their homepage by entering their application number, and password in the '**Integrated Five Year LLB 2026-Candidate Portal**' provided in the website. By clicking the menu '**Allotment Result**' candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo and the candidate shall take a print out of the allotment memo. Candidates can log on to their Home Page and then click the Menu '**Data Sheet**' for downloading the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on any date from **18.08.2026 to 21.08.2026, 3.00 PM**.

Candidates should report along with the allotment memo and original documents specified in Clause 19 of the Prospectus. They should remit the complete fee as per Government orders and other fee in the allotted college at the time of admission. Candidates will be liable to pay at the revised rate

as and when the fee for the academic year 2026-27 in the Law colleges are revised. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **21.08.2026, 4.00 PM**.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)No.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

Candidates, who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments. The details regarding further allotments will be notified later.

*Note: Candidates who have claimed SC/ST reservation have been provisionally considered for allotment as their caste status is under scrutiny by KIRTADS. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.*
