**NOTIFICATION**

**ENTRANCE EXAMINATION FOR ADMISSION TO**  
**INTEGRATED FIVE YEAR LLB COURSE 2025**  
**APPLICATIONS INVITED**

Applications are invited for the Computer Based Entrance Examination for Admission to **Integrated Five Year LLB Course 2025-26** in the four Government Law Colleges in Kerala and in the Private Self-Financing Law Colleges in Kerala having seat sharing agreement with the State Government.

1. **Eligibility for Admission**

**i. Nativity:-** Applicant should be an Indian Citizen. However only those candidates who are of Kerala origin are eligible for any type of reservation or any of fee concession. [See clause 9(i) of the Prospectus].

**ii. Academic Qualifications:-**

- a. Candidate should have passed the Higher Secondary Examination of the Board of Higher Secondary Education, Kerala or any other examination recognised by the Universities in Kerala as equivalent thereto.
- b. A candidate who has passed an examination in 10+2 Course of schooling recognised by the educational authority of the Central or State Government or possesses such academic qualifications which are considered equivalent to such 10+2 course by the Bar Council of India can also apply for admission to the course. Applicants who have obtained +2 Higher Secondary pass certificate or first degree certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission. The applicants who have obtained 10+2 or graduation/post-graduation through open school system/ universities directly without having any basic qualification for prosecuting such studies are not eligible for admission. OR A 3-year Diploma/Polytechnic Course, after 10th Standard, issued by an Institution recognized by the Government shall be considered at par with +2 Certificate for the purpose of admission to the 5 year Integrated LLB Degree Course.(See clause 9 ii of the Prospectus)

- c. Candidates who are appearing/ appeared for the qualifying examination are also eligible to apply for the Entrance Examination. Such candidates become eligible for admission only if they produce the Pass Certificate and Mark List of the qualifying examination at the time of admission.
  - d. No candidate shall be admitted to the Course, unless he/she has passed the qualifying examination with a minimum of **45%** marks. However, candidates belonging to Socially and Educationally Backward Classes and differently abled candidates need only **42%** marks and those belonging to the Scheduled Castes/Scheduled Tribes need only **40%** marks in the qualifying examination. No rounding off of percentage of marks to the nearest higher integer is permitted.(See clause 9 ii (c) of the Prospectus).
- iii. **A g e:-** The applicant should have completed 17 years of age as on 31.12.25. The upper age limit for admission to the Integrated Five Year LLB Course-2025 will be subject to the final order of the Hon'ble Supreme Court of India.
2. **Entrance Examination:-** The Computer Based Entrance Examination will be on **25.05.2025 (Sunday)** to be conducted at centres across all districts in Kerala. **Detailed time schedule in this regard will be notified later.** The questions of the entrance examination will be based on **General English, General Knowledge Arithmetic & Mental ability and Aptitude for Legal Studies. The Entrance Examination will be of two hours duration and will consist of 120 objective type questions of three marks each [Total: 120 x 3= 360].** For every wrong answer one mark each will be deducted.
3. **Qualifying Standards in Entrance Examination: -** To qualify and thereby figure in the rank list for admission to the Integrated Five Year LLB Course, a General/SEBC category candidate should get a minimum of 10% of total marks in the Entrance Examination and a candidate belonging to SC/ST category should get a minimum of 5% of total marks, the total marks being 360 in the Entrance Examination.
4. **Submission of Online Application and Application Fee:-** The application fee is **Rs. 900/-(Rupees Nine Hundred only)** for General and SEBC candidates and **Rs. 450/-(Rupees Four Hundred and Fifty only)** for SC/ST candidates. Candidates seeking admission to the course can apply online through the website **www.cee.kerala.gov.in** of the Commissioner for Entrance Examinations till **14.05.2025, 05.00 PM** and should remit the required application fee within the date by way of online payment. Net Banking/Debit Card/Credit Card facility can be used for Online Payment. Candidates who have applied online and have remitted the fee successfully should upload documents to prove Nationality, Date of birth, recent passport size colour photograph, signature, communal reservation, special reservation, EWS, Income for fee concession within the above mentioned date. No need to send the printout of the application to the Office of the Commissioner for Entrance Examinations.
- 5 . **Certificates/Documents to be uploaded in the Online Application (in PDF format from 10 kb to 500 kb)**

- Proof for Nationality and Nativity as mentioned.(See Prospectus clause 9 (i) (Mandatory).
  - Certificate to prove age: Relevant page of SSLC/Birth Certificate/Passport
  - Non-Creamy Layer Certificate (for State Educational purpose) from the Village Officer in the case of SEBC/OEC candidates.(Annexure XI)
  - Community Certificate from the Village Officer in the case of OEC candidates who do not come under Non-Creamy layer category.(Annexure XV)
  - Non-Creamy Layer Certificates/Community Certificates/ Income Certificates from the Village officer in the case of candidates belonging to the communities listed in Annexure IV (b).
  - Community Certificate obtained from Tahsildar in the case of SC/ST candidates, also refer Prospectus Clause 12c, Annexure XII.
  - Inter-Caste marriage certificate: Candidates who are children of Inter-Caste married couple of whom one is SC/ST, need to upload **Inter-Caste marriage Certificate** issued by Tahsildar (See Prospectus Clause 12 b (iv)).
  - The candidates eligible for EWS Quota seats should submit the EWS Certificate from the Village Officer in the prescribed format Annexure IX (a), IX (b) of Integrated 5 LLB Prospectus.
  - Certificate in support of special reservation, if any, in the prescribed format, (See Prospectus clause 11). ( Annexure VII(a), (b), VIII (a), (b) )
  - Certificate from the District Medical Board for Persons with Disabilities (if applicable) (See Prospectus clause 12(e).
  - Certificate from the Fisheries Officer concerned of Kerala Fishermen Welfare Fund Board for fee concession in the case of candidates who are the children of registered Fishermen.(Annexure XIV)
  - Certificate from the Director, Department of Women & Child Development or from authorities concerned for fee concession in case of candidates who are inmates of Sri Chithra Home, Nirbhaya Home, Juvenile Home or any other such institution run by the Government.
6. Candidates will not be allowed to include any additional information in the application form or to submit any certificate / document claiming reservation or any benefits, after the submission of the online application.
  7. Certificates uploaded in the prescribed format available along with the online application alone will be accepted for claiming special reservation. Candidates eligible for various reservation can submit e-certificates issued by the Revenue Officers concerned.
  8. **Admit Card:-** The candidates registered for the Entrance Examination can download their Admit Cards from the website **www.cee.kerala.gov.in**. The date of issue of

admit card will be notified later. Admit card should be brought to the examination along with valid ID proof.

9. **Allotment of Seats:-** Allotment will be made by the Commissioner for Entrance Examinations in accordance with the ranks obtained by the candidates in the Entrance Examination and the order of preference of institutions (options) registered by the candidates during online Centralised Allotment Process (CAP) (see Prospectus clause 18 for more information). The details of CAP will be notified in the website of the Commissioner for Entrance Examinations and in leading newspapers. Individual intimation in this regard will not be sent to the candidates.

The Computer Based Entrance Examination and subsequent allotments will be based on the provisions laid down in the Prospectus for Admission to Integrated Five Year LL.B Course 2025-26 available in the website **[www.cee.kerala.gov.in](http://www.cee.kerala.gov.in)**. Candidates are advised to read carefully the Prospectus before submitting their online applications.
