## ALLOTMENT TO LL.M COURSE 2021-22 ONLINE OPTIONS INVITED

Centralised Allotment Process for admission to LL.M Course in four Government Law Colleges and Private Self-financing Law Colleges of the State for the year 2021-22 will commence on 21.12.2021. All Candidates who have been included in the rank list for admission to LLM Course 2021 can register their options online through the website www.cee.kerala.gov.in.

Candidates may enter their Application Number & Password in the link 'LL.M 2021-Candidate Portal' provided in the website <u>www.cee.kerala.gov.in</u> to log on to their home page. Then by clicking the menu item 'Option Registration', candidates can register their options online from 21.12.2021 to 27.12.2021, 3.00 pm. The allotment based on the rank list, category list and the online options received up to 3.00 pm on 27.12. 2021 will be published on 29.12.2021. Candidates who fail to register their options online will not be considered for allotment under any circumstances. Options forwarded to the Commissioner for Entrance Examinations by Email/Fax/Post/Hand delivery will not be processed or considered on any account for the allotment of seats. Candidates who get allotment shall have to join the allotted colleges from **30.12.2021 to 04.01.2022, 3.00 pm**.

Annual Tuition Fee, Deposit amount, other fees for the LL.M Courses should be remitted in the allotted colleges at the time of admission.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.

## Documents to be produced at the time of Admission

- 1. Candidate's Data Sheet.
- 2. Allotment Memo issued by the Commissioner for Entrance Examinations.
- 3. Original Mark list of LL.B. examinations (All Mark Lists)
- 4. Provisional/Degree Certificate
- 5. Any other documents mentioned in the Allotment Memo
- 6. Transfer certificate
- 7. Conduct certificate from the Head of the institution where the candidate studied last or that from a Gazetted Officer, obtained within the last six months
- 8. Four copies of passport size photograph of the candidate
- 9. Candidates who passed their qualifying examination from Universities/Boards outside the State shall produce "Eligibility Certificate/Equivalency Certificate" from a University in Kerala, to the effect that the qualifying examination has been recognized by the University.
- 10. Applicants who are employed or trainee in Government service, Scheduled Bank etc. should produce a relieving order and a certificate of good conduct from the Head of the office where they are employed at the time of admission.
- 11. Originals of all the documents/certificates uploaded along with the online application (to prove nativity /reservation/fee concession).

## Note:

Foor

- 1) <u>Candidates are advised to file options to the courses/colleges to which they are sure to join</u> and continue studies if allotted, at the time of registration of options.
- 2) The candidates whose results in the rank list have been withheld due to defects in Nationality, Nativity, Signature, Photo, Fees can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they Upload the required documents through Candidate portal to clear the defects and release their ranks before 2 pm on 24.12.2021.
- 3) <u>Candidates who do not take admission within the specified dates shall lose their allotment as</u> well as their higher options. They will not be eligible for future online allotments, if any, under centralized Allotment Process (CAP)
