## ADMISSION TO LLM COURSE-2024 SECOND PHASE CENTRALIZED ALLOTMENT PUBLISHED

The Second Phase of the Centralized Allotment Process (CAP) for admission to LLM Course in Government Law Colleges and Private Self-financing Law Colleges for the year 2024-25 is published in the website **www.cee.kerala.gov.in**. Final Allotment List has been published after addressing the valid complaints received from candidates regarding the Second Phase Provisional Allotment List published on 16.12.2024.

Candidates can access their homepage by entering their application number, and password in the **'LLM 2024-Candidate Portal'** provided in the website. Then by clicking the menu **'Allotment Result'** candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo. The allotment memo is required to be submitted before the respective college authorities at the time of admission. Candidates can log into their Home Page and then click the Menu **'Data Sheet'** for downloading the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on any date from **18.12.2024 to 21.12.2024**, **4.00 PM** along with the allotment memo and original documents specified in Clause 19 of the Prospectus. They should remit the complete fees as per Government orders to the allotted college at the time of admission. Candidates will be liable to pay the fees at the revised rate as and when the fee for the academic year 2024-25 in the Government Law colleges are revised by the Government. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **21.12.2024**, **5.00 PM**.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational

concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

Candidates who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments will be notified later.
