ADMISSION TO LLM COURSES-2024 FIRST ROUND STRAY VACANCY ALLOTMENT PUBLISHED

The First round Stray Vacancy Allotment List for admission to LLM Courses for the academic year 2024-25 in the Government Law Colleges and Private Self Financing Law colleges of the State, is published in the website **www.cee.kerala.gov.in**. Allotment is based on the rank in the rank list of LLM course published by the Commissioner for Entrance Examinations and online options registered by candidates for the first phase stray vacancy allotment .

Candidates can access their homepage by entering their Application number and Password in the "LLM 2024- Candidate Portal" provided in the above website. Then by clicking the menu 'Allotment Result', candidates can view their Allotment details and can download their Allotment memo. The details such as candidate's name, roll number, allotment, tuition fees, deposit if any etc., are available in the Allotment Memo. Candidates shall also log into their Home page and click the Menu 'Data Sheet' for downloading the Data Sheet.

Candidates should report for admission before the Principal of the allotted colleges on or before **08.01.2025**, **3:00 PM** along with the allotment memo and original documents specified in Clause 19 of the Prospectus, and should remit the fee as shown in the allotment memo at the college. Candidates

should remit the balance fees, if any, as per Government orders in the allotted college at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/ Children of Fisherman/ Inmates of Sree Chitra Home/Nirbhaya Home/ Juvenile Home are exempted from remitting tuition fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on or before 08.01.2025, 4.00 PM.

Candidates who do not join the college within the stipulated time will lose their present allotment.

General Conditions

- 1. The seats received through stray vacant seat allotments cannot be changed at any instance.
- 2. Candidates who are allotted a seat in the vacant seat allotment and stray vacancy seat allotments (irrespective of the admission status) will not be eligible for any subsequent allotments.
- 3. Candidates who have an admission will not be considered for stray vacancy allotments and college level allotments even if they have registered options in this phase.
- 4. After the first round Stray vacancy seat allotment, if vacancies exist/arise, such vacancies shall be filled through Second Round Stray Vacancy Filling Allotment. For subsequent Stray Vacancy Filling rounds, options registered by candidates during the First Round Stray Vacancy Seat Allotment will not be considered.
- 5. Those who have vacated the seat after 23.12.2024, 12:00 PM are not be eligible for stray vacancy round allotments even if they have registered options in this phase.
- 6. Allotment shall be subject to the final order/affiliation/approval of the

Govt./University concerned.

Note: Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be provisional and subject to final verification of their caste status.
