NOTIFICATION ADMISSION TO LLM COURSE-2025 VACANT SEAT ALLOTMENT - FINAL LIST PUBLISHED

The Online Final Vacant Seat Allotment to the to LLM course 2025 to fill up vacant seats in the Government and Self Financing Law colleges is published in the website **www.cee.kerala.gov.in**. The Vacant Seat Allotment has been prepared after addressing valid complaints received within stipulated time regarding Provisional Allotment List published on 23.12.2025. The Vacant Seat Allotment has been prepared on the basis of the conditions stipulated in the LL.M 2025 Prospectus clause 18.

To view the Allotment Result, candidates should log on to the 'LLM 2025-Candidate Portal' by submitting their Application Number and Password. Then by clicking on the link 'Allotment Result', candidates can view their Allotment Result. It is necessary to take the printout of the Allotment Memo. The allotted candidates should report for joining at the allotted colleges from 26.12.2025 to 30.12.2025 3.00 PM, along with all required documents specified in the Allotment Memo as per Prospectus clause 19.

General Rules of Vacant Seat Allotment:

- 1. If no seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, shall prevail, and if a seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, will stand cancelled and the candidate shall have to accept the new allotment.
- 2. The seats received through vacant seat allotment cannot be changed further at any instance.
- 3. Candidates who are allotted a seat in the vacant seat allotment (irrespective of the admission status) will not be eligible for any subsequent allotments.
- 4. Allotment shall be subject to the final order/affiliation/approval of the Government/University concerned.
- 5. The Vacant Seat Allotment Registration Fee of those candidates who do not join the seat allotted through Vacant Seat Allotment will be treated as penalty and will not be refunded.

After the Vacant Seat Allotment, if vacancies exist/arise, these vacancies shall be filled through Stray Vacancy Filling Allotments. Stray Vacancy Filling Allotments, if any conducted, will have fresh option registration opportunity. But already admitted candidates and candidates who are allotted a seat in the vacant seat allotment (irrespective of the admission status) will not be considered for stray vacancy filling rounds. Notification regarding the same will be issued later and the decision of Commissioner for Entrance examination is Final in this regard.
