ALLOTMENT TO PG HOMOEOPATHY COURSES -2021 MOP-UP ALLOTMENT- OPTION REGISTRATION FACILITY ENABLED

The activities related to mop-up allotment for admission to PG Homoeopathy Courses in the Government Homoeo Colleges for the year 2021-22 will commence on 23.03.2022.

All Candidates who have figured in the rank list published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 4 in the Government approved PG Homoeopathy Prospectus for the year 2021-2022 can participate in this Mop up phase. However, those candidates who are blocked from further participation in State Quota allotments on account of being admitted in an All India Quota seat or allotted a seat in the Third (Mop up) Round of the All India Counseling will not be considered for allotment. Also candidates who have obtained admission in Government Merit seats for a course in Government Homeopathic Medical Colleges of the State through State allotment will not be eligible to participate in the Mop up Counseling for any of the subjects in other Government Homeopathic Medical Colleges.

Candidates are advised to choose and order their options cautiously respecting the following conditions:

- i. The options registered by the candidates for this Round could be the basis for the subsequent Stray Vacancy Filling Allotments, if any. In that case, there will not be separate option registration or confirmation step prior to those allotments and the candidates will not be considered for Stray Vacancy Filling Allotment to those courses and colleges not chosen by them in the Mop up Allotment. So, failure to register options in this round will make the candidate ineligible to get an allotment not only in this round but in subsequent Stray Vacancy Filling Allotments also.
- ii. Any candidate who is allotted a seat in this (Mop up) Round or any subsequent Stray Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be considered in subsequent allotments.
- iii. If any candidate already holding a seat allotted in a previous round, wants to participate in the Mop up Allotment he/she should surrender that seat, by obtaining TC from the College concerned before 5 PM of 23.03.2022 and get it reported by the college to the CEE on the same day. Candidates will not be allowed to leave the seat allotted to them in any round, once the option registration of this (Mop up) round ends, except the ones caused by an up gradation to a higher option during the allotment process of this (Mop up) round.
