**ADMISSION TO PG HOMEOPATHY COURSES-2025**  
**FIRST PHASE CENTRALISED ALLOTMENT PUBLISHED**

The First Phase of Centralised allotment for admission to PG Homeopathy Courses for the academic year 2025-26 is published in the website **www.cee.kerala.gov.in**. To view the allotment result, candidates should log on the '**PG Homeopathy 2025-Candidate portal**' by submitting their Application Number and Password. By clicking the link '**Allotment Result**', candidates can view their allotment result.

The allotment memo is available in the above link and it is necessary to take a printout of Allotment Memo. Data sheet also be downloaded from the menu 'Data Sheet'. The allotted candidates should report for joining the allotted colleges **before 01.10.2025, 3.00 PM** along with the printout of Data Sheet, Allotment Memo and the documents specified in the Prospectus. He/She shall pay the fee as specified in the allotment memo at the allotted college.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (Ms)25/2005/SCSTDD, dated 20.6.2002 and G.O(Ms)dated 10/2014/BCCD, dated 23.5.2014, and those candidates from Sree Chithra home, Juvenile home, Nirbhaya home and Children of registered fishermen as per G.O(Ms)47/14/FPD dated 9.6.2014 allotted against merit seats are exempted from remitting tuition fee.

All the college authorities should approve the list of admitted candidates

through Online Admission Management System (OAMS) at **4.00 PM on 01.10.2025**

No extension of time for reporting at the college will be granted under any circumstances. The allotted candidates who do not take admission in the respective college before the time specified will lose his/her present allotment as well as all the higher order options. Such candidates will not be considered for further online allotment for the existing options.

**Note:**

1. *Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by Screening Committee have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.*
2. *Allotment to PwD/ service Quota candidates have not been done at this phase and will be included in the second phase of allotment.*
