ALLOTMENT TO PG DENTAL (MDS) COURSES, KERALA-2022
SCHEDULE FOR FIRST PHASE OF ALLOTMENT

The activities related to the first phase of centralized allotment to Post Graduate Dental (MDS-2022) Courses for the year 2022 commenced from **01.10.2022 (Saturday)**.

All the eligible Candidates included in the Kerala State Merit list who have applied for admission to PG Dental Courses 2022 in the State can register their options online through the Website **www.cee.kerala.gov.in** from **01.10.2022 to 07.10.2022, 10.00 AM**.

Candidates shall have to click '**PG Dental 2022-Candidate Portal**' available in the above website and enter their Application Number and Password in order to access their home page. The Candidates can register their options online by clicking the menu item '**Option Registration**' available in the home page.

A security deposit of **Rs. 10,000/-** will have to be paid at the time of option registration. For SC/ST/OEC and other candidate who are eligible for fee concession, **Rs.5000/-** will have to be paid as security deposit. Those candidates who get an allotment and take admission in the first phase, the security deposit will be adjusted to the tuition fee to be paid at the College or if the candidate does not get an allotment in this or subsequent phases, the security deposit will be refunded after the completion of the entire counselling process.

The schedule for the first phase allotment is given below:

01.10.2022	Opening of the option registration facility.
07.10.2022 , 10.00 AM	Closing of option registration facility.
10.10.2022	Provisional allotment list publication

The list of Dental Colleges/Courses to which the Commissioner for Entrance Examinations makes allotment is provided in the Home page of the candidate (List enclosed as Annexure). Candidates can give options as per their priority on the Course/College combinations in the option list. **A candidate need only give options to a Course-College combination if he/she is sure to join the course and college, under the chosen quota, if allotted.** Options registered online alone will be considered for allotment to the courses. Options sent to the Office of the Commissioner for Entrance Examinations via Post/Fax/E-mail will not be processed /considered for allotment to the courses.

Candidates who seek admission under Minority/NRI quota in Self Financing Dental Colleges shall have to register options online to the desired courses/colleges along with other students during the time of online option registration for first phase itself. Candidates who do not register options shall not be considered for allotment under Minority/NRI quota even if they are included in the respective category lists. Though NRI/Minority quota status of the candidates are not finalized at this stage, candidates are allowed to choose all the available course-college-quota combinations. However, options under NRI and Minority quota will be considered for allotment only if the candidate is found eligible for the respective quota based on the documents uploaded with the online application.

Eligible candidates who have been included in the State Rank List prepared by the Commissioner for Entrance Examinations can register options during this phase of counseling based on which and based on rank and category allotment will be published.
