## NOTIFICATION PG PHARMACY (M.PHARM) COURSE 2025 MOP UP ALLOTMENT -FACILITY FOR OPTION REGISTRATION ENABLED

The online Mop-up counseling for allotment to PG Pharmacy courses-2025 has commenced. All eligible Candidates who are included in the M.Pharm 2025 state rank list can register online options for Mop up phase of online allotment, irrespective of admission status. Online Option Registration is mandatory .The Candidates who want to be considered for the Mop Up allotment shall have to log into their Home Page available at the link 'M.Pharm-2025 -Candidate Portal' and access the option registration portal by clicking the "Option registration" link. The candidates can register options from 4.12.2025 to 7.12.2025, 06:00 PM, through the website www.cee.kerala.gov.in. Options registered in the previous phases will not be considered and, therefore, options must be registered afresh in order to be considered for allotment in this phase. The options registered by the candidates will be considered for seat allotment in accordance with the

various provisions under clause 12 of the prospectus. On the basis of options received up to 7.12.2025, 06:00 PM, the provisional allotment will be published in the website www.cee.kerala.gov.in on 8.12.2025. Candidates who receive an allotment in this phase shall have to take a printout of their allotment memo and remit the fee at the allotted college from 11.12.2025 to 15.12.2025(except 13.12.2025 and 14.12.2025) and join the allotted course/college before 4:00 PM on 15.12.2025.
