ORDER

As per the order read as 4th paper above, the Hon'ble Supreme Court
ordered to the Fee Regulatory Committee (FRC) to reconsider the fee for
M.B.B.S course in respect of Believers Church Medical College

Hospital, Thiruvalla, and issued orders expeditiously. The order issued by FRC in compliance with the above judgement was challenged by the Medical College by filing W.P(C) Nos. 26981 of 2021 & connected cases. These petitions were disposed by the Hon'ble High Court as per the order read as 5th paper above, as both parties came into an agreement that if the fee is fixed as Rs.4,85,000/- for the year 2017-18 and in the corresponding manner as has been done in the case of other similar colleges, the fixation of the fee will not be disputed any further by the management.

2) In compliance with the judgement read as 5th papers above, the Fee Regulatory Committee reconsidered the fee for M.B.B.S course from the academic year 2017-18 to 2023-24 in respect of Believers Church Medical College Hospital, Thiruvalla, and issued orders read as 6th paper above, revising the fee for M.B.B.S course for the General Quota (85%) students in the college from the academic year 2017-18 to 2023-24.

3)In the circumstances, Government are pleased to notify the revised fee structure for the MBBS Course in respect of Believers Church Medical College Hospital, Thiruvalla, from the academic year 2017-18 to 2023-24 as fixed by the Fee Regulatory Committee for Medical Education in Kerala as detailed below;

4) The Amount, if any, received by the Medical College from the students in excess of the revised fee shall be refunded to the students. Similarly amount, if any, due from the students as balance fees shall be paid by the students to the Medical College.

5) The tuition fee, special fee and other eligible fees in respect of SC/ST/OEC students admitted for the course in 2017-18 to 2023-24 will be sanctioned to the colleges by the Director of SC/ST Development Department at the rates fixed by the Fee Regulatory Committee for Medical Education in Kerala.

6) All previous Government Orders fixing the fee for MBBS course in respect of Believers Church Medical College Hospital, Thiruvalla, for the academic year 2017-18 to 2023-24 stands modified to the above extent.

7) The judgement read as 5th paper above complied with accordingly.
