**SECOND PHASE ALLOTMENT TO PG AYURVEDA COURSES -2021**  
**ONLINE OPTION CONFIRMATION IS MANDATORY**

The second phase of centralized allotment to PG Ayurveda courses in various Government Aided and Self Financing Ayurveda Colleges for the year 2021 has commenced from 14/02/2022.

Candidates who have already got allotment in Ayurveda Colleges through first phase of allotment should confirm their online options if they want to be considered for second phase of allotment. All the candidates except those who are willing to continue with their current admission got through first phase allotment must login to the candidate portal and confirm the options if they want to participate in the subsequent phase of the Centralized Allotment Process. Online option confirmation is mandatory for those who have got admission and for those who have no allotment as per the prior allotment PG Ayurveda Course conducted by the CEE in order to be considered in this phase of allotment. Those who got admission in the first phase allotment and do not confirm their higher order options, if any, the admission in the first phase shall be retained.

Candidates who want their options in PG Ayurveda courses to be considered for this phase of allotment shall have to log into their Home Page available in '**PG Ayurveda 2021 – Candidate Portal**' and confirm their options by clicking the '**Confirm**' button available therein. After **Online Option Confirmation**, candidates can rearrange their higher order options or delete the unwanted options from **14.02.2022 to 17.02.2022, 10.00 AM**, through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment based on online options received within stipulated time will be published on 18.02.2022.

**The schedule for second phase of allotment is given below:**

<b>14.02.2022</b>	Website opens for Online Option Confirmation/re-arrangement of higher options/deletion of unwanted options
<b>17.02.2022 10:00 AM</b>	Time for Online Option Confirmation and re-arrangement/deletion ends.
<b>18.02.2022</b>	<b>Publication of Allotment</b>
<b>19.02.2022 to 24.02.2022 2:00 PM</b>	<b>Joining time for allotted candidates</b>
<b>24.02.2022, 3.00 PM</b>	College authorities to approve and submit the list of admitted candidates through Online Admission Management System (OAMS) for PG Ayurveda course.

Candidates allotted to the courses/college should remit the fee mentioned in the Allotment Memo at the college allotted and take admission as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not take admission within the stipulated time will lose their allotment as well as the claims for further centralized allotments, if any. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home, children of fishermen need not remit fees.
