**ADMISSION TO PG AYURVEDA DEGREE COURSES-2025**  
**THIRD ROUND STRAY VACANCY ALLOTMENT**  
**Facility for Option Registration Enabled**

The Third Round Stray Vacancy Allotment to PG Ayurveda Courses-2025 will be conducted as per the schedule given below. In this round, fresh option registration facility is available to the eligible candidates. Current vacancy status is published in the website. If new vacancies arise due to any candidate quitting his/her currently admitted seat, before the upcoming seat allotment process, those vacant seats will also be included in the allotment process. As applicable category conversions of seats will take place in this stray vacancy allotment, while registering options for the stray vacancy allotment, candidates are advised to take into account those probable vacancies too that may arise due to the applicable category conversions. **Therefore, candidates are advised to register options to any seat they wish to join if allotted, irrespective of the current vacancy status of that seat, as any vacancy that may arise before or during the upcoming seat allotment process will also be included in the seat allotment process. The options registered in this stray vacancy allotment will not be considered for further Stray vacancy seat filling rounds, if any.**

**The schedule for the Third Round Stray Vacancy Allotment**

**Conditions:**

Those candidates who have not registered in Round I/ Round 2/ Round 3/SVR-1/SVR-II shall have to pay registration fee for fresh registration.

Those who have already been admitted will not be eligible to participate for further

allotments.

Those who have got allotment in third round allotment/ SVR-1/SVR-II will not be eligible to participate for further allotments.

The options registered in the previous rounds will not be considered for stray vacancy round allotment. Hence, candidates shall have to register option afresh if they wish to participate in the stray vacancy round allotment.

If any candidate does not join seat allotted in third round stray vacancy allotment, he/she may exit with forfeiture of registration fee and cannot participate in further rounds of allotment.

If a candidate freshly register in stray vacancy round and is not allotted any seat, he/she is eligible to participate in further stray vacancy rounds, if any.

Candidates getting allotment in stray vacancy round shall not have any claim on earlier rounds' allotted seat.

Any candidate who is allotted a seat in this phase or any subsequent Stray Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments.

Those candidates who are included in the list of candidates prohibited from participation in further allotments, shared by the AACCC, which is available in the website, will not be considered for the stray vacancy round allotment.

Those candidates who are blocked from further participation in state quota allotments on account of being admitted in AIQ seat will not be considered in this and subsequent phases of the state admission procedures and candidates allotted a seat in the third round and stray vacancy rounds of the All India Counseling will also be ineligible to participate in this and subsequent phases of the state allotments.

Option registration is a mandatory step of this phase irrespective of whether options were registered or not registered in the previous phases. The options have to be registered through the Online Option Registration facility accessible after logging on to the Candidate portal on the website, [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) by giving the Application Number & Password through the link “**PG Ayurveda - 2025 Candidate Portal**”. Then by clicking the Menu ‘**Option Registration**’, candidates can register their options online within the stipulated time.

#### **Registration Fees:**

Those candidates who have not taken part in option registration in Round I/ Round 2/ Round 3/SVR 1/SVR II shall have to pay registration fee for fresh registration. A registration fee of Rs.2,000/- will have to be paid at the time of Option Registration. Candidates belonging to SC/ST/OEC category eligible for benefits as per G.O(Ms)No.25/2005/SCSTDD dated:20.06.2005 and G.O (Ms)No.10/20104/BCDD dated:23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechitra Home will have to remit Rs.1,000/- as option registration fee. Registration fee can be remitted by way of online payment. The registration fee of those candidates who do not get allotment will be refunded. If a candidate gets allotment and does not join within the stipulated time, the option registration fee will be considered as penalty and will not be refunded. Option registration fee of the candidates who quit the seats after taking admission will be considered as penalty and will not be refunded. Refund of option registration fee for the eligible candidates will be made only after the completion of allotment process and it will be notified.

#### **Facility for correcting defects in the online application**

Those who have defects in their online application shall click the menu ‘**Memo Details**’

available on the Home page and upload the required documents /certificates to correct the defects before 10 AM on 19.01.2026. The required documents should be uploaded online and not to be sent to the Office of the Commissioner for Entrance Examinations. As per the provisions laid down in the prospectus, candidates belonging to the Keralite category alone are eligible for any type of reservation or fee concession. If defects in nativity are not rectified within the stipulated time, reservation claims for such candidates will be cancelled even though they have submitted certificates to prove their reservation claim. No other chance will be provided to rectify the defects in the online application
