**NOTIFICATION**  
**ADMISSION TO PG MEDICAL COURSES-2021**  
**MOP- UP ALLOTMENT : REVISED SCHEDULE AND GUIDELINES**

The State Mop-up Counselling for PG Medical courses for the academic year 2021-22 was put on hold as per the Press Release published on 1.4.2022. This was done in view of the cancellation of allotment of Mop-up Round of All India Counselling and conduction of Special round of Counselling in lieu with the Judgement dated 31/3/2022 issued by the Honourable Supreme court in WP(C) No.174/2022. Further, those candidates who were permitted to surrender their seats as per the procedure laid down in the Kerala Government approved prospectus for admission to PG Medical courses were given choice to rejoin their surrendered seats before 5.00PM of 9/4/2022 in compliance with the verdict by the Honorable Supreme Court in WP(C) 202/2022 dated 7.4.2022. Thus, those candidates holding a State PG Medical seat as per the status taken at 5.00PM of 9/4/2022 are considered as admitted candidates of Round 2 and the list of such candidates has been forwarded to Medical Counselling Committee in response to the DGHS letter dated 5th April 2022 directing the state authorities to do so.

Keeping in view the unprecedented situation of cancellation of All India Mop-up Round and reversion of candidates back from the All India allotment, the schedule for Kerala State Mop up is being revised as under and the following provisions are being given for the round.

**18.4.2022 to 19.4.2022, 4.00PM-** Provision for surrender of seats for participation in the State Mop up Round (It may be noted that these candidates will be eligible to participate in the State Mop up Round only)

**20.4.2022 to 21.4.2022, 4.00PM-** Provision for fresh option registration for State Mop up Round.

**The following candidates are eligible for registration of fresh options in State Mop up Round**

1. Those candidates who have not got any allotment or are not holding a Kerala State PG seat as on 19.4.2022 5.00 PM.
2. Those candidates who have surrendered their allotted seat/rejoined Round 2 seat complying with the Notification from this office dated 8.4.2022, before 19.4.2022,

4.00PM.

3. Those candidates who are not holding a seat of All India Round 1 , Round 2 or Special Round and as per the guidelines of MCC.

**Points to be noted.**

- A candidate getting allotment in All India Mop up Round will be excluded from the State Mop up allotment list based on the list provided by the MCC.
- The candidates should register options to those Course- College combinations they wish to study as those vacancies which may arise during the Mop-up phase will also be filled based on the options given,without further notice.
- In case vacancies exist /new vacancies arise after Mop-up allotment these will also be filled in the subsequent phase i.e., Stray vacancy filling round based on the options given for the Mop-up allotment.
- The date of allotment will be notified subsequently taking into consideration the schedule of All India Mop-up.
- Seat once allotted in State Mop up Round will be final.
- Mere transfer or surrender of seat is not permitted
- Surrender of seats after allotment in the Mop up counselling will not be permitted. Hence the candidates have to take due diligence while opting for any course
- Also, candidates have to carefully consider the State as well as All India Regulations for Mop up Round while taking decisions as no further opportunity will be available for anyone.
