ADMISSION TO PG MEDICAL COURSES-2024 **FIRST PHASE CENTRALISED ALLOTMENT PUBLISHED**

The First Phase Centralised Allotment to PG Medical Courses for the academic year 2024-25 in the Government Medical Colleges, RCC Thiruvananthapuram and Private Self Financing Medical Colleges in the State is published in the website **www.cee.kerala.gov.in**. The allotment is based on the rank in the Kerala State merit list published by Commissioner for Entrance Examinations and online options filed by the candidates from **18.11.2024 to 23.11.2024**. The allotment has been published after addressing the valid complaints received from candidates against the provisional allotment published on 25.11.2024. The allotment result is available in the above mentioned website of the Commissioner for Entrance Examinations.

To view the allotment result, candidates should log on **the 'PG Medical 2024-candidate portal'** by submitting their Application Number and Password. Then by clicking on the link **'Allotment Result'**, candidates can view their allotment result. Candidate's who have an allotment should take a printout of Allotment Memo from the home page.

The allotted candidates should report for joining the allotted colleges from **28.11.2024 to 04.12.2024, 4.00 PM** along with the required documents (as per prospectus clause 10.1.22) specified in the allotment memo. The fee, should be remitted at the allotted college during admission. The allotted candidates who do not take admission in the respective college before the time specified will lose his/her present allotment as well as all the options and such candidates will NOT be considered for second phase allotment. Also a candidate who vacates the seat joined in phase I will not be considered for phase II allotment.

The list of participating Medical Colleges in the allotment process and the tuition fee applicable to each college have been given in the notification dated 18.11.2024 published in the website.

Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status. Also those candidates, who have uploaded sworn affidavit of sponsor in case of memo for defect rectification in visa validity expired/expiring for NRI claim, have been included provisionally for first phase allotment. Their Allotment/admission in NRI quota seats, if any, will be cancelled if they fail to submit the document as prescribed within the stipulated time and will not be considered for NRI seats in further allotment.

All the college authorities should approve the admitted candidates through Online Admission Management System (OAMS) at **5.00 PM on 04.12.2024**.

All details related to the allotment process are available on the website www.cee.kerala.gov.in. Candidates are required to visit the official website of the Commissioner for Entrance Examinations regularly for updates.
